4.2 That, in order to maximize the prospects of our company's lease being renewed and our mine being re-opened, our company commits to ensure environmental rehabilitation is carried out in accordance with the terms of reference developed be the UNEP in cooperation with the ABG; and we immediately invite an independent jurist of outstanding achievement, to make a full enquiry into the involvement of our company in the counter-insurgency operations conduced around the time of the mine closure and make recommendations as to appropriate redress for an pass wrongdoing; that we release the resulting report for public scrutiny; and that any proposal to restart the mine should await, recognize and address the outcomes of that enquiry and commit to obtaining free, prior and informed consent (FPIC) particularly of the communities closest and most exposed to the impact of the mine.
